Directions to ROCKBURN FIELDS:

From Route 29 take Route 100 east to first exit – Long Gate Parkway. At second light make a right onto Rt. 103 / Montgomery Rd. Travel 2-3 miles and make a left onto ILCHESTER RD. Go past Ilchester Elementary and make a right onto LANDING ROAD. Park entrance will be on your right.

From 95 – Take Rt. 100 East to Rt. 1 North. Make a left onto MONTGOMERY RD. Travel ~1.5 miles and make a right onto LANDING ROAD. Park entrance will be on your left.

DIRECTIONS TO CEDAR LANE PARK WEST:

From Route 29 – Take Rt. 108 West. From Rt. 108 turn left onto Cedar Lane (opposite Howard County Board of Education building). Park entrance is approximately ¼ mile on your left.

From Route 32 – Take Rt. 108 East. From Rt. 108 turn right onto Cedar Lane (opposite Howard County Board of Education building). Park entrance is approximately ¼ mile on your left.
